The status report (zone wise list and scheme wise) of the various schemes namely **"Post-Matric & Pre-Matric scholarship scheme for SC students, Post-Matric & Pre-Matric scholarship scheme for OBC, Mukhyamantri Vidhyarthi Pratibha Yojna and Reimbursement of Tuition Fees for students belonging to SC/ST/OBC"** for the academic session 2023-24 & 2024-25 is available in Annexure A.

Also, it has been observed that the applications received under various Centrally Sponsored & State Funded scholarship/welfare Schemes in the Academic Session 2024-25 are fewer than the previous academic sessions. Schools of respective zones/districts are hereby advised to **expedite the verification of pending applications of aforesaid scholarship schemes for the year 2023-24 & 2024-25 latest by 20.02.2025** so as to enable DSCST to process these cases further and make/facilitate payment of welfare/scholarship benefits to the applicants well in time.
