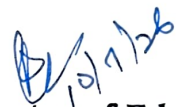

Instructions to the Inspection Teams

1. All teams shall carry out inspections strictly as per the inspection schedule issued by the District Office.
2. The team members will be treated on duty till the completion of inspections.
3. The inspection shall be conducted using the prescribed Student Safety Checklist and other instructions issued by the Directorate of Education.
4. The teams shall physically verify all provisions relating to POCSO compliance, child safety measures, infrastructure, CCTV, transport safety, staff verification, awareness programmes and other parameters prescribed in the circular.
5. Observations shall be recorded accurately and supported with documentary evidence/photographs wherever required.
6. The Team Leader shall ensure that the inspection is completed thoroughly and objectively.
7. Any serious violation affecting the safety and security of students shall be brought to the notice of the Deputy Director of Education immediately.
8. The EVGC shall compile the inspection reports received from all teams and maintain the district-wise record.
9. All inspection teams shall submit the duly signed inspection report to the CIC on the same day of inspection or latest by the next working day, without fail.

10. Delay in submission of inspection reports shall be viewed seriously.
11. The teams shall maintain confidentiality of all information collected during the inspection and adhere to the provisions of the POCSO Act, 2012.

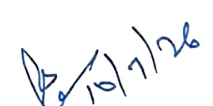
This order shall come into force with immediate effect and shall remain valid till completion of the inspection programme.
