CIRCULAR

Subject: Regarding integration of scholarship scheme portal run by every state government with UDISE*/AISHE from the Year 2024-25

Kind attention is invited to the letter letter No F.No.11(242)/SCH/DSCST/2024-25/7010-11 dated 29.04.2024 received from Dy. Director (Scholarship/Link Officer), GNCT of Delhi regarding the integration of scholarship scheme portal run by every state government with UDISE*/AISHE from the Year 2024-25 with reference to Ministry of Social Justice and Empowerment, Government of India, letter dated 05.10.2023 and letter dated 25.10.2023

Ministry of Social Justice and Empowerment, Government of India, on the subject cited above has given instruction regarding Aadhar-based Biometric e-KYC of all INOs/DNOs/SNOs/ HOI on priority and it also intimates that from AY 2023-24, Minsitry has decided for the mandatory Aadhaar based eKYC of all Institute Nodal Office/District Nodal Office/State Nodal Office/ Head of Institute. The expenses for the biometric authorization of the INOs / HOI in the institution which are on boarded on NSP will be borne by the concerned Ministry/Department in Government of India. Biometric authorization of the INOs / HOI in the Institution not mapped with NSP or where details of the institution are not on NSP are requird to be completed by the respective State Governments/UT administration and expenses in such cases will be borne by the State/UTs.

On the same matter, the Directorate of Education has already issued a circular dated 14.03.2024 (copy enclosed) regarding the Biometric Authentication of DNOs/INOs and HOI on priority which states that Department of Social Justice and Empowerment has executed a MoU with CSC e-Governance Services India Ltd which in collaboration with NSP has initiated the bioauthentication of INOs, HoIs, DNos and SNOs in the States/UTs by organizing different camps at different institute/State Departments.

In view of the above, all DDE(Districts), DDE(Zones) and concerned Head of all types of school may be requested to provide the full cooperation /support to CSC so that Biometric Authentication drive for all DNO/HoI/INO/beneficiaries of Central Sector Scholarship schemes of Pre and Post Matric Scholarship for SC students may be completed within the aforementioned stipulated timelines.
