**CIRCULAR**

**Subject: Revised timeline for various scholarship schemes on National Scholarship Portal for minority community students for the academic session 2022-23.**

Kind attention is invited to our earlier circulars dated 04.08.2022, 26.08.2022, 29.08.2022, 09.09.2022, and 11.10.2022 regarding launching of CSS schemes & verification of applications under various Scholarship Schemes for minority communities on National Scholarship Portal for the academic session 2022-23. In this regard, Ministry of Minority Affairs (MoMA), GoI has issued the following revised timeline for Scholarship Scheme for the year 2022-23:

Further, Head of all type of Schools are requested to arrange effective dissemination of this information regarding revised timelines of aforesaid CSS schemes on NSP so that eligible students may apply within the time limit of respective scheme and **also ensure that INO must expedite verification process at Institute level (L-1) so that no application remains pending for verification. In case, if any single application remains unverified then the eligible student will be deprived of their scholarship benefit and its responsibility will lie on concerned Head of School.**
