The **Jeevan Raksha Padak Series of awards 2022** are granted in the following three categories:-



2.	Uttam Jeevan Raksha Padak	:	Awarded for courage and promptitude in saving life under circumstances of great danger to the rescuer.
3.	Jeevan Raksha Padak	:	Awarded for courage and promptitude in saving life under circumstances of grave bodily injury to the rescuer.

The recommendations for this award are considered by Awards Committee within a period of two years from the date of performance of the gallant act. **Therefore, for the year 2022, any recommendation in respect of which the date of performance of the act falls prior to 1<sup>st</sup> October, 2020 should not be forwarded to their office for consideration.**

The recommendations for the awards are to be forwarded alongwith the bio-data, a detailed citation in narrative form, clearly bringing out the sequence-wise details of the incident as well as the specific role/contribution of the person (rescuer), is to be forwarded in each case, **so as to reach in the office of Dy.Secretary, Home (Gen), Home (General) Department, A-Wing, 5<sup>th</sup> Level, Delhi Sachivalaya, I.P.Estate, New Delhi-110002 by 31<sup>st</sup> July, 2022.** The recommendations for the Jeevan Raksha Padak of Awards can also be sent through the online portal designed by the Ministry of Home Affairs (**URL : [www.jrp.mha.gov.in](http://www.jrp.mha.gov.in)**).
